Terms & Conditions:-

1. This engagement will be for a period of One year/44 days as applicable in the pay matrix level-11 plus usual allowances admissible as per rules.
2. Private Practice: The Private practice of any kind whatsoever is strictly prohibited. Besides the candidates will not work simultaneously in any other Hospital/Charitable Organization.
3. Breach of this condition will result in termination of appointment/disciplinary action as per rule.
4. The engagement will not bestow any claim or right with the incumbent for regular appointment to the post.
5. House Rent Allowance: Hostel accommodation is optional and subject to availability of rooms. The entitlement for HRA will be as per Govt. You will have to vacate the Mpl. Hospital accommodation if allotted on the date of expiry of your term of appointment.
6. Experience certificate: No experience certificate will be issued unless the full term is completed.
7. Your services are liable to be terminated at any time at the discretion of the Authorities without assigning any reason.
8. No salary will be paid for any kind of unauthorized absence from duty even in the name of strike.
9. The appointment will be subject to Medical Fitness Certificate.
10. You will have to produce your original Degree/ Diploma and DMC Registration for verification at the time of joining

11. It is mandatory to complete the contract period. If she/he wants to resign from the post, 01 month notice or 01 month salary in lieu of notice period is required.
12. You will not be entitled to any travelling allowances for joining the assignment.
13. Other conditions of services will be governed by the relevant Rules from time to time.
14. A Demand draft of Rs. 2,000/- (Rupees Two Thousand only) in favor of Commissioner MCD will be made at the time of joining as security deposit. This amount can be enhanced. The amount is refundable at the conclusion of your appointment on the production of No Dues Certificate.
15. Senior Residents can be posted as Casualty Medical Officer and have to discharge the duty Of CMO and any other duties assigned from time to time by the Head of the department/Medical Superintendent.
16. While on duty you will not leave the hospital without prior and written permission of the HOD/Unit In-charge.
17. The tenure of Senior Resident will be for a period of one year or 44 days in case of selected against category seat and will be renewed based on work and conduct report. Total period of appointment of a candidate as Senior Resident shall however not exceed a period of three years.
18. Entitlement of leaves as per rules.
19. The doctor at any time found guilty of any gross misconduct or negligence, his/her duties shall be terminated without any notice or payment in lieu of notice period.
20. After completion of tenure/resignation, the resident doctor must obtain 'No Dues Certificate' from all concerned department within one month for release of final payment/ salary/ experience certificate/ security deposit. Delay in completing the formalities may delay the release of salary and this will be his/her responsibility.
21. If any declaration given or information furnished by the candidates proved to be false or found to be willfully suppressed, Candidate will be liable to be removed from service or such other action as deemed appropriate / necessary by the authority.

In case the post is acceptable by you on the above mentioned terms and conditions, you may report for duty in the office of the undersigned on or before 15.07.2026, otherwise the selection/offer will be deemed to be automatically cancelled.
